IT IS DEFINITELY POSSIBLE FOR CITIZENS OF OTHER EU COUNTRIES TO LIVE IN SWEDEN AND WORK IN DENMARK. EVERY DAY, ABOUT 15,000 PEOPLE CROSS THE STRAIT FROM THE SWEDISH TO THE DANISH SIDE TO WORK. ALL YOU NEED TO DO IS TO TAKE CARE OF SOME PRACTICAL THINGS.

CPR-NUMBER AND TAX-CARD

In Denmark each person has a personal registration number, which is called a CPR. You apply for a CPR number by using a form on SKAT's website. Read more at oresunddirekt.com about what to do and what kind of documentation you need to attach.

HEALTH INSURANCE CARD AND DENTAL CARE CERTIFICATE

When you work in Denmark, you are also entitled to use the Danish health care system. In order to do this, you need a special health insurance card. In order to get subsidised dental care in Sweden, you need to apply for a dental care certificate from the Swedish Social Insurance Agency.

BANK ACCOUNT

When you start to work in Denmark, you need to open an account in a Danish bank, a so-called NemKonto. Do this as soon as possible once you have your CPR number.





NEMID

NemID is a personal digital signature that you can use in your bank, unemployment fund and insurance company, as well as in various governmental agencies such as SKAT and borger.dk. NemID consists of a user ID, a password and a key card.

WORKING IN TWO COUNTRIES

Working in both Sweden and Denmark may have financial consequences for your employer and may also affect you and your employment.

UNEMPLOYMENT FUND AND TRADE UNION

Do you live in Sweden, work in Denmark and want to be a member of an unemployment fund and/or trade union? Then you should choose a Danish option, as Swedish trade unions and unemployment funds do not have any influence in the Danish labour market. Remember that it is important to register at a Danish unemployment fund already on your first day of working in Denmark.

PENSION

The Danish public pension system is very different from its Swedish counterpart. Therefore, study the pension agreements where you work.
